 Name of Product: Tumble Dryers
 Distribution: National
 Hazard: If the defect occurs there is a risk of fire.
 Product Defect: There is a potential for lint/fluff to dislodge from the rear drum seal and fall near the dryer heater and become ignited.

Date of Recall: 22nd January, 2016
 Name of Product: Water Bottle
 Distribution: National
 Hazard: If the defect occurs there is a risk of choking.
 Product Defect: The rubber top on the bottle may become loose during use resulting in it detaching from the bottle.

Date of Recall: 19th January, 2016
 Name of Product: Sander
 Distribution: National
 Hazard: If the defect occurs there is a risk of electric shock.
 Product Defect: A defect of the ventilation wheel could cause a break of the device housing.

| Name of Product: | Frame |
| Distribution: | National |
| Hazard: | If the defect occurs there is a risk of laceration. |
| Product Defect: | The frame joins can easily separate when handled or hung on the wall, allowing the glass to fall and break. |
| Date of Recall: | 14 th January, 2016 |
| Name of Product: | Wooden Drum Sticks and Tongue Drum |
| Distribution: | ACT, NSW, QLD, SA, VIC & WA |
| Hazard: | If the defect occurs there is a risk of choking. |
| Product Defect: | The rubber ball on the drum sticks may become loose and detach during use. |
| Date of Recall: | 11 th January, 2016 |
| Name of Product: | Dining Chair |
| Distribution: | ACT, NSW, QLD, SA, TAS, VIC & WA |
| Hazard: | If the defect occurs there is a risk of laceration or entrapment. |
| Product Defect: | The tapering of the inside bottom of the chair legs may lead to an entrapment or laceration hazard. |
| Date of Recall: | 22 nd December, 2015 |
| Name of Product: | Baby Bird Toy |
| Distribution: | WA |
| Hazard: | If the defect occurs there is a risk of choking. |
| Product Defect: | Small parts may detach from the product. |
| Date of Recall: | 12 th November, 2015 |
| Name of Product: | Glass Cooktops |
| Distribution: | National |
| Hazard: | If the defect occurs there is a risk of electric shock. |
| Product Defect: | Accessible parts may not be effectively earthed. |
| Date of Recall: | 10 th November, 2015 |
| Name of Product: | Electric Blanket |
| Distribution: | National |
| Hazard: | If the defect occurs there is a risk of fire. |
| Product Defect: | The control cord may fatigue and cause an internal short circuit or overheat. |

| Hazard: | If the defect occurs there is a risk of burns. |
| Product Defect: | Burners may not align correctly with the gas delivery jets. Upon ignition the gas within the barbecue burner is likely to light at the jet rather than only at the burner ports. |
